All puppies and adults are as accurately described as possible and are guaranteed to be healthy and "as we have represented" at the time of the sale. Our animals are priced according to pedigree, quality, breeding history and/or possible future potential. We make no guarantees implied or otherwise that any animal sold will gain any type of show title, but that they exhibit certain potential and a possibility of doing so based on our evaluation at the time of the sale. Any known faults will be discussed with the buyer before a puppy is purchased. Arizona Border Collies reserves the right for pick of the litter on any and all litters.

The Seller will register the puppy/dog with the American Border Collie Association, Inc., under the name listed above and provide the registration papers to the Buyer. The Buyer has the option of registering their puppy/dog with the American Kennel Club (AKC). Registrations will be submitted for by 12 weeks of age for the puppies and if a name is not provided a generic name will be submitted to ABCA.

Ownership of the puppy/dog will be transferred to the Buyer for the sale price of \$700.00 (US) to be paid as follows: \$200.00 deposit on execution of the Agreement with the balance of \$500.00 to be paid on or before the puppy/dog leaves Arizona Border Collies premises. If the balance is not paid by \_\_\_\_\_ (DELIVERY), this Agreement shall be cancelled and the Buyer forfeits the deposit given hereunder. Final payment must be paid in the form of cash, PayPal or if paid by check it must clear prior to picking up puppy.

Arizona Border Collies guarantees that the puppy is in good health on the date of delivery. Puppies will visit the veterinarian three times prior to leaving for its new home. Between six and eight weeks of age, Arizona Border Collies will have puppy checked by a veterinarian, vaccinate and dewormed. The Buyer has the right to return the puppy to the Arizona Border Collies within three days after delivery, if the puppy is found by a veterinarian to be suffering from any disease.

If, as a result of the examination, the Veterinarian determines that the puppy/dog is not in good health then the Buyer shall elect to keep the puppy/dog or return the puppy/dog to the Seller for a refund. If the buyer elects to return the puppy, Buyer shall, within 10 days after the date of the signing of this contract, send to Seller by certified mail a written Veterinarian's certificate stating that the puppy/dog was in ill health when examined. Upon receipt by Seller

of said certificate, Buyer shall be obligated to return the puppy/dog to Sellers at Buyers expense. Upon receipt of the puppy/dog, the Seller shall be obligated to refund all monies received from Buyer toward the purchase price of the puppy/dog, and further performance under this contract shall be null and void. Arizona Border Collies has the right to request a second opinion from a different veterinarian. All action taken to return the puppy/dog shall be done with the best interest of the puppy/dog in mind include temperature at time of shipment, non-stop flights, etc.

Arizona Border Collies Seller warrants that the puppy/dog sold hereunder is progeny of animals penn-hip scored and normal for Collie Eye Anomaly (CEA). If said puppy/dog develops hip dysplasia, PRA or CEA, within two years from date of birth, the Buyer may return the dog to Seller and will receive a replacement puppy/dog of like quality from the next available litter, or may keep the dog, which will be spayed or neutered, and Seller will refund \$ 200.00.

If Buyer chooses a replacement puppy/dog, Buyer and Seller shall make prompt arrangements within 10 days of receipt of certified letter and Veterinarian certification for return of the puppy/dog sold herein to Arizona Border Collies in Goodyear, Arizona. Buyer shall be responsible for taking good and reasonable care of the puppy/dog until Seller receives it. Costs and related expenses of returning the puppy/dog to Seller shall be the obligation of the Buyer. Buyer may keep the dog if he/she so desires, but must present certification by a veterinarian if the complaint is hip dysplasia, or by a veterinary ophthalmologist if the complaint is PRA or CEA. The Arizona Border Collies does not assume any additional liability for possible genetic defects in the puppy, and will under no circumstances be responsible for veterinary bills resulting from any such condition.

The puppy shall not be bred unless it shall first (1) have been x-rayed and certified clear of hip dysplasia by OFA or has received their penn-hip score, and (2) have been certified clear of hereditary eye disease by a canine ophthalmologist.

The Buyer shall maintain the puppy in good condition, including adherence to a regular veterinary supervised immunization schedule, heartworm preventative, good diet, and a clean and safe environment.

If delivery is requested by Buyer, it shall be by airfreight, prepaid to a designated location. Buyer is responsible for costs of crate, insurance during shipment, health certificate and cost of freight charges. All shipping fees must be paid in full prior to actual shipment of puppy.

Buyer agrees that he/she is not acting as an agent in the purchase or this puppy/dog and that Buyer will not sell this puppy/dog or its progeny to any agent, pet store or guard dog business.

Arizona Border Collie puppies/dogs may be returned due to unforesee/unfortunate issues, no funds will be returned and the puppy/dog will be rehomed if possible.
